Objective

At the end of this presentation you will be able to know how to use Ascente – Mobile Pro to dispatch technicians to service orders that are linked to Job Cost Jobs. This makes it possible to utilize the benefits Mobile Pro provides for the Service module, with the Job Cost module.

Technicians will be able to:

- Apply labor hours and costs to the job
- Apply parts, quantities and costs to the job
- Add Jobsite component records for major equipment added to the job



Benefits

- Your office will be able to dispatch technicians to Job Cost – Jobs just as they do for service calls.
- Technicians can do all the entry for labor and material used from the field.
- Your office will not need to do these entries or try to read the technicians writing because the technicians are doing their labor and part entries.
 Your office still has the final say and gets to review, edit and update the technician's entries.



Benefits

When the entries are done by the technicians at the time of service:

- The entries will get to the office sooner.
- No more waiting for paperwork from the technicians.
- Office operations should get done faster.
- The Job Cost Reporting should be more current.
- Technicians may not need to come into the office as much.


Cost Application

- All costs for the Job Cost Job entered in Mobile Pro will be applied to the Job and not to a work order. No work order labor or parts records will be created.
- Mobile Labor entries will update from Mobile Pro to the Ascente – Timecard records so timecards can be edited, reviewed and updated by the office in Ascente.
- Mobile Part entries will all result in Ascente Inventory to Job records, unless linked to a purchase order, so they can be edited, reviewed and updated by the office in Ascente.



Labor Hour/Cost Entry

Labor entry in Mobile Pro for a Job Cost – Job is no different than it is for service other than you will be prompted for a cost code.



Labor Hour/Cost Entry

After the labor is entered in Mobile Pro and the 'Upload Call to Server' is done, the labor entry can be seen in the Ascente – Timecard program where you can review, edit and update the labor hours.

Parts Quantity/Cost Entry

After the part is entered and the 'Upload Call to Server' is done, the part entry can be seen in the Ascente – Inventory to Job program where you can review, edit the entrees. The Inventory to Job Register can be used to update the entrees.

Component Records (Adding & Viewing)

Mobile Pro makes it possible for technicians to add component records for major equipment installed on the job's associated jobsite record. This information is very valuable for support, maintenance contract processing and marketing purposes.

Considerations, Recommendations & Questions ...

How will the technicians know what Cost Code to select?

You will need to provide them with that information. A cost code is required for service orders linked to a Job Cost - Job. It can be edited by the office before the entries are updated.



Considerations, Recommendations & Questions ...

Can I filter the Call Inquiry for only Job Cost Calls?

If your company has dedicated technicians for only Job Cost – Jobs, in the Ascente – Call Inquiry you may want to filter the calls by supervisor. That will make it possible to just see the Job Cost or Service calls without having them all on one screen. Just assign the technicians to the appropriate supervisor (*Job Cost or Service*).



Considerations, Recommendations & Questions ...

Why are no cost codes available when I go to select a cost code?

You most likely did not enter an estimate for the Job with estimated costs.



Considerations, Recommendations & Questions ...

Do I have to add a service order for each technician that is going to work on the same job?

No, you can schedule multiple technicians to the same service order.



Considerations, Recommendations & Questions ...

Do I need to invoice or cancel the service order I created for the job when all work has been performed?

You should never invoice the service order used for the Job Cost – Job, that is done in the Ascente - Job Cost module. You can X-Cancel or zero invoice the service order if you like. These will clutter up the Call Inquiry and cause performance issues if they are not removed. They serve no further purpose.



Considerations, Recommendations & Questions ...

Can I add a purchase order for a part?

Yes, you can do this from Parts Entry
